- **Fee for Local Use** - \$5 fee at the time of registration. **NOTE:** For a list of participating counties refer to the "Fee for Local Use - Participating Counties" Fact Sheet.
- **Circus-Carnival Plates** (Trucks or Truck Tractors only) - Valid from April 1 through September 30 of any year. Use the appropriate chart (Trucks/Truck Tractors) to determine the registration fee for the proper registered gross weight of the vehicle and divide that fee in half. **NOTE:** Circus-Carnival Plates are not eligible for two-year registration.
- **Commercial Implements of Husbandry** - \$110 or one-half of the fee in the Regular Trucks/Truck Tractors column, whichever is greater.
- **Farm Equipment Dealer Plates** - \$349 or one-half of the fee listed in the Regular Trucks/Truck Tractors column, whichever is greater.
